



Riverside Medical Opts for Fix-a-Form for Self-Test Breathalyser

Fix-a-Form helps with campaign to encourage broader, positive change in attitudes to responsible alcohol consumption.

With society struggling with the challenges caused by alcohol abuse and alcohol related incidents, (en)¹⁰ provides low cost, simple and accurate tools that encourage broader, positive changes in attitudes to responsible alcohol consumption.

(en)¹⁰'s flagship product, Chube, is a single-use disposable breathalyser which has just been awarded the NF mark, of the type now compulsory for anyone driving in France to carry in their car. Riverside Medical, makers of Intelligent and innovative packaging solutions for the healthcare sector ranging from plasters to hip joints, helped to specify the multi-page Fixa-Form from Denny Bros that is featured on the self-test product.

The generously-sized 6-page informational Fix-a-Form,

35mmx133mm at its finished size, is wrapped neatly around the tube that drivers blow into to check if they are over the limit. Yellow granules inside the tube turn green if alcohol above the tube's preset level is detected.

The tubes are packed in multiples in a handy blister pack, a concept devised by Riverside Medical in partnership with **(en)**¹⁰. The product, which also contains a reader card for grading the results of the tests, is now being distributed for widespread use in France.

According to a Riverside Medical spokesperson, the idea is simple but hugely effective. "When we were approached by (en)¹⁰ to help develop the packaging for the idea we immediately thought of Fix-a-Form."

"It is widely known that it can accommodate any amount of text and images and be applied in almost any way to a product even one with hardly any surface area – in this case a thin tube."





Holidaying to France or passing through?

If you're venturing to France for your holidays this summer or plan to pass through then you'll need to be aware of the latest rules and requirements:

Breathalysers

All motor vehicles and motorcycles (excluding mopeds) must carry 2 breathalysers. The regulation was enforced from 1 November 2012 and anyone now stopped who fails to produce a breathalyser may receive an on the spot fine of €11. With the French drink driving limit at just 50mg compared with the UK's 80mg – having just the one drink clearly isn't worth the risk.

Sat Nav and Speed Camera

French laws now prohibit drivers from carrying any device capable of detecting speed cameras. This includes devices able to warn or inform of the location of speed cameras e.g. satnav or gps systems capable of showing speed camera sites as Points of Interest.

Warning Triangles

A legal requirement now across Europe should your vehicle break down.
